The Colorado Riparian Association (CRA) is pleased to announce a \$4,000 scholarship available to graduate students for the 2024–2025 academic year. Completed application packages must be received by **5pm MST on 6/7/2024**, interviews will be held in late June, and the successful candidate will be notified in mid-July.

Purpose and Eligibility Requirements

The Colorado Riparian Association’s mission is to “promote the conservation, restoration, and preservation of Colorado’s riparian areas and wetlands” (visit coloradoriparian.org for more information). The goal of this scholarship program is to engage students in the mission of CRA and the ecological community. Applicants must be enrolled in a 2024 – 2025 graduate program that supports CRA’s goals at a college or university in Colorado and be registered to take at least 3 credit hours of coursework per semester. Eligible programs of study include, but are not limited to, ecology, biology, fluvial geomorphology, hydrology, hydrogeology, watershed management, or a river or watershed focused engineering program. The scholarship recipient will receive a complimentary registration and lodging for the 2024 Sustaining Colorado Watersheds Conference, held October 8 – 10, 2024 in Avon, CO. The scholarship will be awarded to the winner at the conference, where the recipient will share a poster presentation on their research project or proposal. Selection Process

Three applicants will be short-listed based on this application and a brief essay (approximately 500 words; attach to application) describing their research, their personal and career goals and how they relate to the goals and mission of CRA, as well as how they would use the funds if received. Finalists will be notified of their status in mid-June. A panel of CRA board members will hold a short (approximately 20-minute) interview with the finalists shortly thereafter. The successful candidate will be notified by 7/19/2024.
